ABSTRACT

The World Bank Enterprise Survey (WBES) is a firm-level survey of a representative sample of an economy's private sector. The surveys cover a broad range of topics related to the business environment including access to finance, corruption, infrastructure, competition, and performance. The follow-up survey follows the baseline WBES and is designed to provide quick information on the impact and adjustments that AI has brought about in the private sector.

WEIGHTING

The dataset contains two weight variables. The baseline weights from the ES are denoted wt_ES. Since not all the firms interviewed in the baseline participated in the follow-up survey, the weights are adjusted so that the follow-up sample remains representative of the original survey universe. Therefore, final weights were constructed by chaining the baseline sampling weights with a second - stage adjustment factor.
